

CONSENT TO THE PROCESSING OF PERSONAL DATA

according to Act No. 110/2019 Coll., on processing of personal data, and on the basis of Regulation (EU) 2016/679 of the European Parliament and of the Council of 27 April 2016 on the protection of natural persons with regard to the processing of personal data and on the free movement of such data, and repealing Directive 95/46/EC (General Data Protection Regulation).

1 IDENTIFICATION OF THE CLIENT (DATA SUBJECT)

2 PERSONAL DATA

Personal data is any information relating to an identified or identifiable natural person (Data Subject); An identifiable natural person is one who can be identified, directly or indirectly, in particular by reference to an identifier such as a name, an identification number, location data, an online identifier or to one or more factors specific to the physical, physiological, genetic, mental, economic, cultural or social identity of that natural person.

4 SCOPE OF PERSONAL DATA PROCESSING

The Controller processes personal data to the extent that they were provided to the Controller by the Data Subject in connection with an order for the transport of human tissues and cells (distribution) in accordance with Directive 2004/23/EC of the European Parliament and of the Council, or Act No. 296/2008 Coll., on Human Tissues and Cells and its implementing regulations (e.g. name, surname, date of birth, permanent address and other contact details such as contact address, telephone number, e-mail address, other data such as bank details and other data necessary for the the distribution). The Controller shall also process personal data not provided by the Data Subject but obtained in connection with the distribution or in connection with the handling of complaints or requests. Personal data is processed by the Controller in accordance with the valid and generally binding legal regulations of the Czech Republic and for the fulfilment of its legal obligations.

5 PROCESSING AND PROTECTION OF PERSONAL DATA

Personal data is processed in particular in documentation related to distribution and in full compliance with applicable legal regulations. Their security and protection is ensured in accordance with these regulations. The processing is carried out manually in paper and electronic form or automatically by means of computer technology, in compliance with security principles for the management and processing of personal data.

6 RECIPIENTS OF PERSONAL DATA

Personal data may be disclosed to healthcare providers who receive or send tissues and cells or to other tissue and cell distributors when cooperating in the distribution.

Recipients may be processors under contract with the Controller to the extent of data necessary for the purpose of the processing, e.g. when ensuring the storage or archiving of data, persons providing legal or other advice and state authorities within the framework of the fulfillment of legal obligations established by relevant legal regulations

7 PURPOSES OF PERSONAL DATA PROCESSING

We process your personal data for the purpose of: compliance with legal obligations on the part of the Controller; execution of distribution; determination, exercise or defence of legal claims (legitimate interest of the Controller); keeping records of income and expenses, payments received and management; provision to the extent strictly necessary for legal, economic and tax advisors and auditors for the purpose of providing advisory services to the Controller (legitimate interest of the Controller); Storage and archiving of documentation according to applicable legislation.



Your contact details will be used for the purpose of communicating with you via phone, email or other communication channels (WhatsApp and others). If you provide us with your telephone number, you also agree that communication with you may take place via a telephone call or other communication channel. If you provide us with your e-mail address, you also agree that we will communicate with you via e-mail. At the same time, you declare that you understand that the technical security of the e-mail is limited. By providing your consent, you acknowledge, among other things, that in the event of unauthorized access to a mobile or other communication device, there is a risk of unauthorized access to your personal data, especially if your communication password is disclosed or your e-mail address is accessed without authorization. The e-mail address and telephone number provided by you may also be used to verify the quality of the services provided and your satisfaction, or to communicate regarding our new services or the scope of their provision.

8 PERIOD OF PROCESSING OF PERSONAL DATA

The Controller processes personal data for the period necessary to fulfil the given purpose. In relation to the necessary traceability of tissues and cells during the transport, the period of archiving of your personal data is set by law at 30 years

9 RIGHTS OF THE DATA SUBJECT

You have the right with our company as a personal data Controller to following: request access to your personal data from us; request correction of your personal data that we process; withdraw consent to the processing of personal data; request restriction of processing (does not apply to legal requirements); request the erasure of personal data (this does not apply to data necessary to maintain traceability); raise an objection to the processing (in the event that we process your personal data for the purposes of our legitimate interests or those of others); request data transfer (to provide your data to another controller on the basis of your written consent); request information about the status of the processing of personal data; lodge a complaint with a supervisory authority (if you believe that the processing of personal data violates data protection legislation). You can lodge a complaint with the supervisory authority of your habitual residence, place of employment or place where the alleged breach occurred. In the Czech Republic, the supervisory authority is the Office for Personal Data Protection, Pplk. Sochora 27, 170 00 Prague 7, www.uoou.cz.

The processing of your personal data for distribution purposes is a legal requirement. Failure to provide your personal data may mean that we are unable to provide you with our services.
